Advertisement for hiring of Indian Dance/Music Teacher

Embassy of India in Asuncion invites application for hiring of Indian Dance/Music Teacher purely on contractual basis for an initial period of one year. Contract can be extended upto 3 years on the basis of outstanding work.

Qualification and experience:

Essential: (1) Candidate should be the citizen of Paraguay or having Permanent Residency of Paraguay or having NRI status with valid work permit; (2) Fluency in English and local language; (3) Candidate should have minimum of 3 years degree with 3 years of experience or 2 years diploma/certificate or training in Indian Dance/Music for a minimum period of 2 years from renowned institution/Guru with 4 years of experience; (4) Adequate knowledge of history, philosophy and traditions of Indian music, dance, art and culture.

Desirable: (1) Experience in teaching of Indian Dance/Music; (2) Sound knowledge in use of computers including recording/downloading audio/video, mixing and editing video from the YouTube/internet; (3) Experience in giving performance/lecture/demonstrations; (4) Should be good at production of stage programmes/choreography and examination preparation. (5) Candidate must be able to take initiative and strive to help students to achieve their personal best with high expectation of attainment, progress and behavior.

Age: Between 25-50 years.

Duties/Responsibilities: (1) Adhere to the timetable established by the Mission, ensuring that classes are scheduled at times convenient for local students. (2) Conduct regular Indian Dance/Music classes as per the established schedule, while actively contributing in additional out-reach activities at other venues, including performances, workshops, master classes etc. (3) Fulfill any other duties as assigned by the Mission.

Courses to be offered:

- a. Children level course for age group 8 to 15; 6 month duration or 48 hours
- b. Beginners course for young students; 6 month duration or 48 hours
- c. Certificate level course for those who have passed Beginner level or having a suitable level of knowledge of the dance form; 1 year duration or 96 hours
- d. Diploma level course for those who have passed Certificate level; 1 year duration or 96 hours

Remuneration: On honorarium basis, with an honorarium of US\$ 500/- per month.
